About Arts Clayton

The Arts Clayton Gallery, a program of Arts Clayton, Inc., is a non-profit Gallery dedicated to enriching lives through the arts. All of the work displayed and available for purchase is original art and handcrafted gifts created by Georgia artists.

Rules and Conditions

Eligibility/Media

All artists, **16 years and older**, are eligible. Artists may submit up to **4 pieces of original two or three dimensional work (excluding photography)**. Only original work by the artist, completed in the **last 3 years**, suitable for viewing by any audience, and produced without instructional assistance will be accepted. Work must be **no larger than 48"X 60"**. Limit for sculpture is 48" vertical and 50 lb in weight

Entry Fees

Up to 4 entries per artist may be submitted for a **non-refundable entry fee of \$30.00**.

All completed entries must be received no later than **May 13, 2021**. Acceptance letters will be mailed, via USPS, no later than May 17, 2021. Artwork to remain on display for entire exhibition.

Sales

Artist agrees to 35% commission on sales of all artwork. Arts Clayton, Inc. will pay all applicable sales tax. **Payment to artists for work sold** will be made approximately one month after exhibit end. Work not for sale must be marked (NFS).

Awards

A Purchase Award for Best of Show is a **sale** of art to the Arts Clayton Gallery Permanent Collection for the retail price of the work, up to \$1200. No Commission is taken on purchase awards. If the retail price of artwork is over \$1200, it is the artist's choice to sell the Best of Show Award Winning work to Arts Clayton Gallery for the maximum amount of the purchase award. Cash equivalent prize is not available. Checks for 1st, 2nd, 3rd places will be presented at the **opening reception and awards presentation**.

Delivery and Return of Work

All work accepted must arrive ready to install, complete with hanging wire and artist information on back of work for identification purposes. Accepted work must be depicted in accepted photo or digital image. If the accepted work differs from the entry image, is not gallery ready, properly framed, is missing framing wire, does not exhibit good craftsmanship or suffers from poor presentation, the work will be omitted.

Work to be hand delivered or shipped to the gallery June 1 - 4 between **10am-1pm**. Work received after 1:00pm on June 4 will be omitted from the show. Artist is responsible for all shipping and insurance fees. Include payment and label for return shipping. Arts Clayton is not responsible for any shipping damage, or issues arising from shipped photographs. **Pick-up for artwork is July 30, 2021 from 10 AM to 1 PM**. All artwork left at the Arts Clayton Gallery 30 days after exhibit's end becomes the property of Arts Clayton, Inc.

Conditions

Arts Clayton reserves the right to: 1) photograph art for publicity purposes; 2) disqualify any entry which does not follow the stated entry specifications and guidelines, including but not limited to, incomplete entry application form and improper entry formatting; 3) reject any artwork at their discretion.

Entry Specifications - for Jury

For Digital Submission:

All files must be on CD Rom, Flash Drive, or sent by email. Format to be opened by a Windows PC.

Send submissions to courtney.hurst@artsclayton.org. Be sure images are oriented properly in standard Jpeg format.

File size must be no larger than 10MB with a minimum resolution of 1024X768. All images MUST be named in the following manner: "Your first name_your last name_entry number.jpg"

Please test all CDs and flash drives prior to submission. Arts Clayton is not responsible for the technical malfunctions in digital materials (corrupted files, unreadable CDs)

Note: Entry images not conforming to the desired formats and requirements listed above will be disqualified.
